## Board Ask Types

Tag	What It Means	What the Board Does
<b>[Awareness]</b>	The board should know about this.	No action required. Read and note.
<b>[Affirmation]</b>	Ministry is moving forward on this and wants the board's support on record.	Affirm or raise concerns.
<b>[Decision]</b>	A choice point that falls within the board's authority.	Discuss and decide.
<b>[Action]</b>	Something the board itself needs to do or assign.	Take or delegate the action.
